No. 1/1/2024-MPSC(Estt): Pursuant to Government's letter No. COMM-1/2/2022-DP-DP dated 14/03/2024, applications are invited from the intending candidates for recruitment of the following posts in Manipur Public Service Commission, Manipur on contractual basis which may be extended as per requirements through sponsorship of concerned Employment Exchange Offices, Manipur.

Note: For the post under Group-D, candidates will be given the options to choose the post according to their merit.

2. Eligibility Conditions:

(i) The candidate must be a citizen of India.

(ii) A candidate must be able to speak Manipuri or any of the Tribal Dialects of Manipur.

(iii) A candidate must be a permanent resident of Manipur. Provided that a candidate whose parent or any of his/her ancestors in his/her direct lineage are/were permanent resident of the State, (with proper documentary proof like Domicile Certificate), then he/she will also be eligible.

(iv) Age Limit: A candidate shall not be less than 21 years and not more than 38 (thirty-eight) years as on 3rd April, 2024. (The upper age limit is relaxable by 5 years for ST and 3 years for OBC for the Group-D posts)

Note: There will be no age relaxation for candidates belonging to categories where there are no reserved posts.

- The willing and eligible candidates for the posts of Drivers and Group D (Peon/ Chowkidar/ Security Guard) shall get their names sponsored by the concerned Employment Exchange Office. The applications of Candidates not sponsored by the Employment Exchange shall be summarily rejected.
- STARTING AND CLOSING DATE FOR SUBMISSION OF ONLINE APPLICATION:
 The online application should be applied at www.empsconline.gov.in w.e.f. 19/03/2024 up to 11:59 PM of 03/04/2024 after which the link will be disabled. Submission of application in any other mode will not be entertained.
- 5. Fee: (i) For the post of Group D -Rs. 200/- for Unreserved Category & OBCs and Rs.150/- for SC/ST.
 - (ii) For the post of Drivers -Rs.300/- for Unreserved Category & OBCs and Rs.200/- for SC/ST.
 - (iii) No fee is payable for DAP (Differently Abled Candidates)
 - Note 1: Candidates should note that payment of examination fee can be made only through online mode by using net banking, Visa/ Master Card/ Debit Card through www.empsconline.gov.in portal. Payment of fee through any other mode is neither valid nor acceptable. Application submitted without prescribed fee/mode shall be summarily rejected.
 - Note 2: Fee once paid shall not be refunded under any circumstances nor can the fee be held in reserve for any other examination or selection.
 - Note 3: For the Applicants in whose case payments details have not been received from the bank, they will be treated as fictitious payment cases and their applications will be rejected in the first instance. A list of such applicants shall be made available on the Commission's website after the last date of their fee payment. On receipt of documentary proof, genuine fee payment cases will be considered and their applications will be revived, if they are otherwise eligible.

- The eligible candidates shall be issued an e-Admission Certificate in the MPSC website http://empsconline.gov.in/downloadadmitcard.aspx for downloading and this shall be notified later in the official website. No admission Certificate will be issued from MPSC Office or sent by post.
- 7. No candidate will be admitted to the Examination unless he/she holds an e-Admission Certificate issued by the Commission for the purpose.

Mere fact that an e-Admission certificate of the examination has been issued to a candidate, will not imply that his/her candidature has been finally cleared by the Commission or that entries made by the candidate in his/her application to the preliminary examination has been accepted by the Commission as true and correct.

8. The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the Examination shall be final. If on verification at any time before or after

the Examination, it is found that a candidate does not fulfil any of the eligibility conditions, his/her candidature for the Examination/ selection will be cancelled by the Commission.

- 9. Withdrawal of applications: No request for withdrawal of candidature received from a candidate after he/she has submitted his/her application will be entertained under any circumstances.
- 10. The Commission reserves the right to amend this notification in parts or to the whole.
- 11. Mobile Phones Banned:
 - (a) Mobile phones, Pager or any electronic communication devices are not allowed inside the premises where the examination is being conducted. Any infringement of these instructions shall entail disciplinary action including ban from future examinations.
 - (b) Candidates are advised in their own interest not to bring any of the banned items including mobile phones/pagers etc. to the venue of examination as arrangement for safe-keeping of the same cannot be assured. Commission will not be responsible for any loss in this regard.
- 12. The scheme of examination, date of examination and other details shall be notified later in the official websites of MPSC.
