Educational and other qualifications: Super Specialty qualification (DM/MCh/DNB(equated to DM/MCh) in any Super Specialty recognized by NMC (erstwhile MCI). Holder of Permanent Registration Certificate of any State Medical Council/National Medical Commission (erstwhile MCI).

Desirable:-Knowledge in Bengali or Kok-borok as per Memorandum of GA(P&T) No.F.20(1)-GA(P&T)/2018 dated 02-01-2021.

Age:- Below 45 years as on 15/02/2025. It will be strictly adhered to save in cases of exceptionally qualified candidates where the age limit be relaxed not more than three year. Relaxable by 5(five) years in case of SC/ST candidates and Government servants candidates However, the SC/ST/Govt. Servant will not get the further relaxation of 5(five) years over and above relaxation of 5(five) years which they are already entitled to get as SC/ST candidates.

To apply for the aforementioned posts, the applicant must have **Permanent Resident Certificate of Tripura (PRTC)**. This is in pursuance of GA(P&T) Department Notification dated 07-07-2023.

The last date of submission of online application is 15/02/2025 (upto 5.30 PM). The application (s) received after the closing date will not be entertained.

\* Selection procedure: The selection process and marks distribution for Specialist Cadre as follows: API=85 Marks and Interview = 15 marks, Total=100 marks as per "Annexure-A"

1) Selection Process:-

- (a) As per Tripura Health Service Rules 2022, the selection process will comprise of 02 (two) successive stage: viz
  - (i) Screening by API Score: 85 marks of API Score.
  - (ii) Interview/ Viva: 15 marks.
- (b) For detailed selection process please refer to Health & Family Welfare Department's Notification No. F.3(457)-HFW/2019 dated 26.10.2022. Short-listing of candidates for Interview as per API Score for Specialist Cadre as per "Annexure-A".
- (c) 15 Marks allotted for Interview/ Personality Test: Assessment of Domain Knowledge in professional field, Practical experience, Presence of Mind & Attitude, IQ etc.
- d) Candidates will be called for the Interview/Personality Test in category wise on the basis of API score in the following ratio:

e) Candidate(s) scoring marks equal to that of the last candidate so selected for the Personality Test will also be called for Personality Test.

f)The final selection will be made in order of merit on the basis of the marks obtained by a candidate (out of 85 marks) and by adding the marks obtained in the Interview process (out of 15 marks). If a candidate remains absent in the interview process, his/her candidature will not be considered for final merit list.

g) In the list of recommendation, merit position of candidates securing equal marks will be finalized as per their seniority of age. The same procedure is to be followed for preparing waiting List, if there be any.

Further provided that, in the list of recommendation, merit position of candidates securing equal marks in aggregate and also of the same age will be decided on the basis of percentage of marks obtained in the minimum educational qualification prescribed in Recruitment Rules/Service Rules.

h)Ranks of the candidates are not prepared for the candidates beyond the recommendation list & wait list (if there be any).

#### Other Important information:-

- 1. Online Application Portal:
- (a) Candidates will have to submit application through Online Application Portal only. The Commission will not entertain any hard copy application. Before submission of online application, read carefully the instruction to candidates.
- (b) Online Application Portal will be available on Commission's website from 22/01/2025 to 15/02/2025 (5.30 PM). Before applying for the post, an applicant shall register his/her bio- data particulars through One Time Profile Registration (OTPR) on the Commission's Website viz. https://tpsc.tripura.gov.in. Once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number and email ID. Applicants need to apply for the post using the OTPR User ID through the Commission's website.
- (c) Applicants should avoid submitting multiple applications. However, if due to any unavoidable circumstances, any applicant submits multiple applications then he/she must ensure that the application with latest Receipt Number is complete in all respect.
- (d) In case of multiple applications, the application with latest Receipt Number shall only be entertained by the Commission and fee paid against one Receive Number shall not be adjusted against any other Receipt Number.
- (a) Candidates are required to submit self attested copy of certificates in support of their claims regarding Age, Educational Qualifications Madhyamik onwards ( all marksheet and certificates All attempt Certificate MBBS, (MD/MS/Diploma/DNB), Specialist(DM/MCh/DNB/Diploma) Publication Super Registration Certificate from any State Medical Council/National Commission(erstwhile MCI), Permanent Resident Certificate, Castes/Scheduled Tribes, Experience Certificates, API score (as per Annexure A) and as per supporting API Score sheet, if mentioned in the application in the receipt section of the TPSC. Submission of such documents will be allowed up to 01.03.2025 along with printed copy of Online Application failing which candidature will be treated as cancelled. The Commission will not entertain any application thereafter.
- b) Applicants must be in possession of the prescribed minimum qualification(s). Mere issue of admission certificate to the candidate will not imply that his/her candidature has been finally cleared by the Commission. On scrutiny of documents, if a candidate found ineligible as per terms & condition of the Advertisement (including prescribed Recruitment fee) his /her candidature will be rejected.

(c) On scrutiny of documents, if a candidate is found ineligible as per terms and condition of the advertisement (including prescribed recruitment fees), his/ her candidature will be rejected. If the application is not routed through Proper Channel, at the day of interview candidates will have to submit 'No-Objection' certificate. In that No-Objection certificate, it is to be clearly mentioned that your employer has 'No-Objection' if you are considered for recruitment to the post for which you have applied for.

## (3) Rate of Recruitment Fees:

- (a) **Group-A Gazetted Posts**:- Rs.400/- (Rupees Four Hundred) only for General Candidates and Rs. 350/-(Rupees three Hundred and Fifty) only for ST/SC/ BPL card holders/Physically Handicapped Candidates.
- b) Recruitment fee so deposited is non-refundable.
- c) If a candidate submits incomplete application in respect of terms & condition of the Advertisement and without requisite recruitment fee, his/her candidature will be rejected.
- 4. Assessment and evaluation of necessary documents done by the Commission shall be final and shall not be open to scrutiny by any external authority.
- 5. Decision of the Commission as to the eligibility or otherwise of a candidate at any stage of the selection process shall be final.
- 6. Candidates are instructed to visit the Commission's website for information regarding steps of recruitment process time to time.
- 7. Candidates are at liberty to make correction(s) in any field(s) of the 'Online Application Form' for the respective advertisement after closing day of submission of online application window of the said advertisement. The window for making correction(s) only will remain open for 7(seven) days from the closing day of submission of 'Online Application Form'.

After completion of such process the Commission will not entertain any application/representation for making correction(s) any field(s) of the 'Online Application Form'.

8. Mobile Phone/Electronic Gadgets etc. are banned in the Campus of the Examination Premises /Interview Premises. Any Phone/ Electronic Gadget found in possession of any candidate in the Examination Premises /Interview Premises shall be confiscated forthwith and he/she may be debarred from appearing at the Examination /interview and also for the Examination(s)/Interview to be conducted by the Commission in future Violation of such instruction will be dealt as per Law.

Candidate must be first, second or Correspondence Author of the publications, otherwise the marks of publications will not be added.
