1. Various posts of Research Engineer cum Trainer (Ex-cadre) are to be filled at CoE/IRISET as shown below:



Desirable Knowledge	Conversant in Architecture of Three Phase and Conventional Electric locomotives, Power Circuit, Control Circuit and Notch Up/Notch Down Mechanisms, Basic understanding of Three Phase and Conventional EMUs, IRAB Brake System: Working of various valves, E-70 Brake system : Working of various valves, Basics of EP Brake System of Multiple Units, Train sets and TCMS in Multiple Units, Train Sets, Microprocessor control of conventional electric locomotives and Propulsion systems of Three Phase Electric Locomotives, Equations of motion and Vehicle dynamics, Basics of Kavach, Cab signalling, Automatic Train Protection and Various requirements of Onboard Equipment for ATP etc.
Eligibility	The applicants should be working as regular SSE/JE in Electrical Department in Loco Shed or Trip Shed or EMU/MEMU car shed or CLI, with a minimum of 21 months of field experience on Railways as on the date of issue of Notification. JE in Level-6, SSE in Level-7, CLIs in Level-7 and SSEs upgraded in Level-8, Level-9 on non-functional basis are eligible to apply.

2. Terms & Conditions

- i. Upper age limit as on the date of notification should be 58 years.
- ii. The applicants should have good service record & communication skills with aptitude for Teaching, Research, Design, Development, RAMS and Training.
- iii. Ability to teach in Hindi and good knowledge in MS Office, CAD will be an added advantage.
3. Candidates who fulfill the above conditions may send the applications in the prescribed proforma as Annexure-I to IRISSET through proper channel. Advance copy application as intimation will also be entertained. And, those candidates also will be allowed to appear for Selection whose application is forwarded by any Controlling Officer prior to written examination.
4. Incomplete applications and applications received after the due date will not be considered.
5. Employees working in ex-cadre post or not having completed the cooling off period of one year from date of repatriation after working in ex-cadre posts in any grade/level are not eligible to apply.
6. The S&T Supervisors already selected/empanelled for the posts of ex-cadre Instructor, TRA & Centre of Excellence and whose currency of panel is not completed i.e. two years from the date of empanelment are not eligible to apply.
7. The selection for the above posts comprises of written examination, classroom lecture trial and presentation with weightage of 60%, 20% and 20% respectively. Presentation will be made by candidate on the innovative and good work done by the candidate. The applicants who have secured minimum 60% marks in the written examination will only be called for Classroom lecture trial and Presentation. The minimum aggregate marks in the selection process are 60%. Panel will be drawn in the order of merit.
8. Role of Research Engineer cum Trainer/S&T (Ex-Cadre) being selected for CoE is stipulated 'to provide expertise and technical inputs in the field of modern signalling and telecommunication and to impart training including teaching. Role of Research Engineer cum Trainer other than S&T (Ex-Cadre) being selected for CoE is stipulated 'to provide expertise and technical inputs in their concerned field and to impart training including teaching. Selected candidates are entitled to draw "Training Allowance" as admissible from time to time as per extant rules.
9. The syllabus for the examination would be the relevant working knowledge required for supervisors in their respective stream.
10. Normal tenure at CoE/IRISSET is 3 years initially which may be extended / curtailed at the discretion of IRISSET Administration.
11. The dates of Written examination, Classroom lecture trial and Presentation would be intimated in due course of time. List of eligible employees for participating in Selection would be published after the scrutiny of applications.
12. Those who have volunteered and attended the exam will not be allowed to withdraw their applications at a later date and should be in readiness to appear for Written examination/Classroom lecture trial/Presentation. Selected employees will not be allowed to decline the post.
13. The lien of selected employees will be maintained in their parent Cadre. The post is classified as ex-cadre, there is no future avenue of Promotion.
14. These posts are ex-cadre, hence all the posts are un-reserved in terms of Railway Board's letter No. 78(E)SCT 15/16, dated 22.06.1983. Since, the selection is conducted by calling volunteers, no supplementary Written exam, Classroom lecture trial & Presentation will be held under any circumstances.

15. Administration reserves the right to increase/decrease the number of posts at any stage as per administrative requirement.


